• A Gift in Your Will. One of the easiest ways to make a legacy or planned gift is to simply name Meher Mount as a beneficiary in your will or living trust. A bequest – a gift in your will or trust – can be for a percentage (most common) or a specific amount.

Here is sample language for your will:

I [name], of [city, state ZIP], bequeath [] percent of my estate (or the sum of \$[]) to Meher Mount Corporation, designated for the Agnes Baron Endowment for Meher Mount, a tax-exempt, nonprofit 501(c)3 organization at 9902 Sulphur Mountain Road, Ojai, CA 93023-9374. Federal Tax ID: 77-0236525.

• Beneficiary Designation. To make a planned gift – <u>without adding to or</u> <u>changing your will</u> – you can make a beneficiary designation. Retirement plans, life insurance policies, or annuities are all options. You can specify a percentage of the value, the entire amount, or a lesser amount.

To designate Meher Mount as a beneficiary, contact your plan administrator or insurance broker to obtain a beneficiary designation form. Here's the information you need to know:

- **Qualified Charitable Distribution.** You can make a *future* gift from your IRA which may have tax benefits for your heirs.

And you can also lower taxable income *now*. If you are 70.5 or older, you can donate up to \$100,000 per year from your IRA. If you are subject to a Required Minimum Distribution (RMD), an IRA gift can help you meet your RMD while lowering your taxable income.
